The undersigned, acknowledges and files in the office of the state of Florida, for the purpose of forming a corporation for profit, in accordance with the laws of the state of Florida, these articles of incorporation as by law provided.

**ARTICLE I**

This provision shall be in addition to any other rights to which those indemnified may be entitled under any By-Laws, agreements, vote of shareholders or disinterested directors or otherwise, both as to action in his official capacity and is to continue as to any person who has ceased to be a director or officer, and shall inure to the benefit of the heirs, executors, and administrators of such a person.
