ARTICLES OF INCORPORATION

SENTIMENTS, INCORPORATED

ARTICLE I - NAME

The name of this corporation is Sentiments, Incorporated, and the mailing address of the corporation is 4703 Hunters Run, Sarasota, Florida 3424 [1] ARTICLE II - CORPORATE EXISTENCE

This corporation shall commence its existence upon the filing of these Articles of incorporation and shall exist perpetually.

Any and all shares of stock of this corporation, whether held by its initial shareholder(s) or any subsequent shareholder(s), may not be sold or otherwise transferred during the life of its shareholder(s) to any other person(s) except the

spouse(s) of its shareholder(s) unless first offered to this corporation for purchase on the same terms and conditions as offered to the other prospective purchaser(s). Any and all such offers shall be fully set forth in writing and this corporation shall have thirty (30) days from receipt thereof to accept any and all such offers. If this corporation does not accept any such offer within thirty (30) days, the offering for sale with the other prospective purchaser(s) upon the terms no more favorable than those offered to this corporation.

ARTICLE VII - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 2033 Wood Street, Suite 115, Sarasota, Florida 34237; the name of the initial registered agent of this corporation at that address is Charles J. Prescott.

ARTICLE VIII - INITIAL BOARD OF DIRECTORS

This corporation shall have two directors initially. The number of directors may be either increased or diminished from time to time by the by-laws but shall never be less than one (1). The names and addresses of the initial directors of the corporation are:
