**ARTICLE I - NAME**

The name of this corporation is MECHANICAL TRADING CO.

**ARTICLE II - DURATION**

The corporation shall have a perpetual existence.

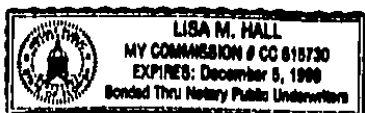

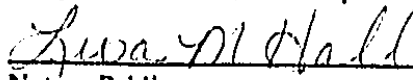
