# ARTICLES OF INCORPORATION OF V & P FOOD, INC.

The undersigned incorporator, for the purpose of forming and corporation under the Florida Business Corporation Act; hereby adopts the following Articles of Incorporation.

#### ARTICLE\_I

# NAME, PRINCIPAL PLACE OF BUBINESS AND DURATION

The name of the Corporation is V & P FOOD, INC. The principal place of business of the Corporation is 2426 13TH STREET ST.CLOUD FLORIDA 34769. The duration of the Corporation is perpetual.

ARTICLE II

### REGISTERED OFFICE AND AGENT

The address of the registered office in the state of Florida is 2426 13TH STREET in the city of ST. CLOUD in the County of OSECOLA. The name of the registered agent at such address is VINAYKANT JOSHI.

#### ARTICLE III

#### CORPORATE PURPOSE, PONERS AND RIGHTS

- 1. The nature of the business to be conducted or promoted and the purpose of the Corporation are to engage in any lawful act or activity for which Corporation may be organized under the Business Corporation Act of Florida.
- 2. In furtherance of its corporate purpose, the Corporation shall have all of the general and specific powers and rights granted to and conferred on a corporation by the Business Corporation Act of Florida.

#### ARTICLE\_IV

#### CAPITAL STOCK

- In the event of voluntary or involuntary liquidation, dissolution of assets or winding up of the corporation, after distribution in full of the preferential amounts, if any, to be distributed to the creditors and holders of shares of preferred stock, if any such stock shall be authorized herein and issued, the holders of Common Stock shall be entitled to receive all of the remaining assets of the Corporation of whatever kind available for distribution to shareholders ratably in proportion to the number of shares of Common Stock held by them respectively. The Board of Directors may distribute in kind to the holders of Common Stock such remaining assets of the Corporation or may sell transfer or otherwise dispose of all the corporation of may sell transfer or otherwise dispose of all or any part of such remaining assets to any other Corporation, trust or other entity and receive payment therefor in cash, stock or obligations of such other Corporation, trust or other entity, or any combination thereof, and may sell all or any part of the consideration so received and distribute any balance thereof in kind to holders of Common Stock.
