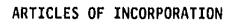

ARTICLE I - NAME

The name of this corporation is

ARTICLE IV - CAPITAL STOCK

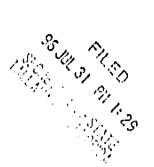
This corporation is authorized to issue 100 shares of No Par Value voting common stock which shall be designated "Voting Common Stock".

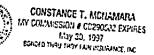
