The undersigned, acting as incorporator of a Corporation pursuant to Chapter 607, Florida Statutes, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is Accommodations Plus, Inc.

ARTICLE II

The Corporation is to have perpetual existence.

ARTICLE III

The purpose of the Corporation is to engage in any lawful act or activity for which corporations may be organized under the corporation laws of this state.

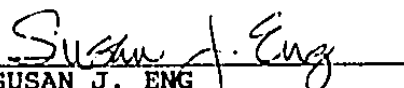
