

ARTICLES OF INCORPORATION J. ROBERT GRIFFIN & ASSOCIATES, P.A.

ARTICLE I NAME OF CORPORATION

The Name of the Corporation is J. Robert Griffin & Associates, P.A. (hereinafter "Corporation").
