ARTICLES OF INCORPORATION

PHOENIX PROPERTIES OF TAMPA DAY, INC.

To the state of th The undersigned, acting as incorporator, hereby adopts these Articles of incorporation and forms a for - profit corporation (the "Corporation") under the laws of the State of Florida, as follows:

L NAME

The name of the Corporation is:

2. TERM OF EXISTENCE

The date when the corporate existence shall commence shall be August 1, 1996, and the Corporation shall have perpetual existence thereafter.

3. PURPOSE
