ARTICLES OF INCORPORATION

GINA ENTERPRISES, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation shall be: GINA ENTERPRISES, INC.

ARTICLE II - TERM OF EXISTENCE

The term of existence of the corporation is perpetual.

Dissolution of this Corporation may be effected by the provisions of the Florida Statutes.


