The undersigned incorporator of REED'S STUCCO, INC. hereby forms a corporation for profit under the Florida General Corporation Act and other laws of the State of Florida.

1. NAME OF CORPORATION AND INITIAL ADDRESS: The name of this corporation shall be Reed's Stucco, Inc. and the initial corporate address shall be 2623 Oak Street, Panama City Beach, Florida 32408.

2. TERM OF EXISTENCE: This corporation shall exist perpetually unless dissolved according to law.
