ARTICLES OF INCORPORATION
OF
DR. EL-SAYED M.D., P.A.

The undersigned, being a duly licensed physician in the state of Florida, for the purpose of forming a professional corporation under Chapter 607 of the Florida Statutes, and Chapter 621 of the Florida Statutes, being the Professional Service Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation shall be:

DR. EL-SAYED, M.D., P.A.

The principal place of business of this corporation shall be 560 NORTHWEST 108TH AVENUE PLANTATION FL 33324.

ARTICLE II. NATURE OF BUSINESS

The sole specific purpose for which this corporation is organized is to practice the profession of medical services; provided, however, that this Article shall not be construed so as to limit the provisions of Section 621.08, Florida Statutes 1987.
