

ARTICLES OF INCORPORATION

OF

NIIPAHP AFFORDABLE HOUSING CORPORATION MICH 1

The undersigned incorporator hereby forms a corporation under Chapter 607 of laws of the State of Florida.

ARTICLE I. NAME

The name of the Corporation shall be:

NHPAHP AFFORDABLE HOUSING CORPORATION MICE

ARTICLE II. NATURE OF BUSINESS
