ARTICLES OF INCORPORATION  
OF  
CUSTOM CULLET CORP.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be Custom Cullet Corp.

ARTICLE II. PURPOSE

The corporation shall engage in the business of processing and recycling materials, primarily glass, obtained from any and all sources, for the purpose of reselling the processed materials at a profit. The corporation shall also perform any or all other lawful activities or businesses permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to issue is 5,000 shares of common stock having no par value.
