

### ARTICLES OF INCORPORATION OF MONA LISA INTERIORS, INC.



The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the Laws of the State of Florida.

#### **ARTICLE 1 - NAME**

The name of this Corporation is:

MONA LISA INTERIORS, INC.

#### **ARTICLE II - NATURE OF BUSINESS**

The corporation may engage in any activity or business permitted under the Laws of the State of Florida and of the United States of America; except that it is not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telegraph, or cemetery company, a building and loan association, mutual life insurance association, cooperative association, fraternal benefits society, state fair or exposition.

#### ARTICLE III - CAPITAL STOCK

The maximum numbers of shares of stock that this corporation is authorized to have outstanding at any one time is Ten Thousand (10,000) shares of Common stock, each share of which is to be of \$1.00 par value. The consideration for the issuance of the aforementioned shares or for the disposal of treasury shares may be paid, in whole or in part, in each or other property, tangible or intangible, or in labor or services performed for the Corporation. Shares may not be issued until the full amount of the consideration for which shares are to be issued shall have been received by the Corporation, such shares shall be deemed to be fully paid and nonassessable and exempt from assessment.

#### ARTICLE IV - TERM OF EXISTENCE

This Corporation is to exist perpetually.

#### <u>ARTICLE V - ADDRESS</u>
