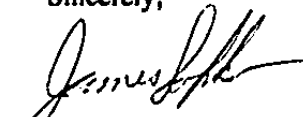

ARTICLE I

NAME

The name of this corporation shall be: TREASURE COAST COMMERCE CENTER, INC.

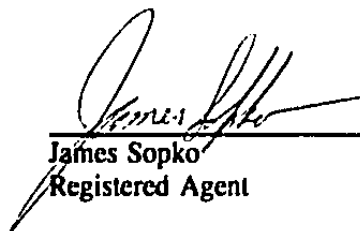
