ARTICLE I - NAME AND ADDRESS

The name of the Corporation shall be **PRINT CENTRAL OF OCALA, INC.** with its principal place of business at 7500 Northwest 14th Street, Ocala, Florida 34482.

ARTICLE II - NATURE OF BUSINESS

This Corporation may engage or transact in any or all lawful activities or business permitted under the Laws of the United States of America, the State of Florida, or any other state, territory, country, or nation.

ARTICLE III - CAPITAL STOCK

ARTICLE VI - BOARD OF DIRECTORS

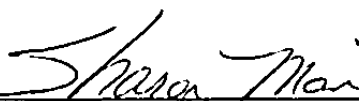

ARTICLE VIII - BY-LAWS

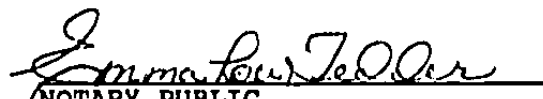
The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and the Shareholders.
