ARTICLE 1

DURATION

ARTICLE 111

PURPOSE

THE PURPOSE OF THE CORPORATION SHALL INCLUDE THE TRANSACTION OF  
ANY AND ALL LAWFUL BUSINESS FOR WHICH CORPORATIONS MAY BE  
INCORPORATED UNDER CHAPTER 607 OF THE FLORIDA STATUTES.

ARTICLE 4

STOCK

THE MAXIMUM NUMBER OF SHARES OF STOCK THAT THIS CORPORATION IS  
AUTHORIZED TO HAVE OUTSTANDING AT ANY ONE TIME IS ONE HUNDRED  
(100) SHARES OF COMMON STOCK, HAVING A PAR VALUE OF ONE (\$1.00)  
DOLLAR PER SHARE WHICH SHALL BE DESIGNATED AS COMMON SHARES.

ARTICLE 5

RIGHT OF SHARES OF CAPITAL STOCK

THE ENTIRE VOTING POWER FOR THE ELECTION OF DIRECTORS AND FOR ALL  
OTHER PURPOSES SHALL BE VESTED EXCLUSIVELY IN THE HOLDERS OF THE  
OUTSTANDING COMMON SHARES, EACH SHARE HAVING ONE (1) VOTE.

NOTHING IN THESE ARTICLES SHALL BE CONSTRUED TO ALLOW FOR  
CUMULATIVE VOTING OF SAID SHARES.

ARTICLE 6

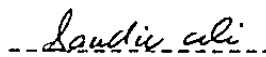

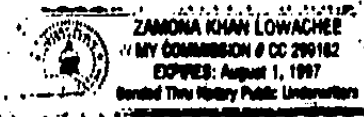
