

ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of EATON, RAMSEY,
TROMBINO & CO. under the Florida Business Corporation Act, adopts

the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation is EATON, RAMSEY, TROMBINO & CO., INC.

ARTICLE II. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence on the date of filing of these Articles of Incorporation.

ARTICLE III. PURPOSE

This corporation may engage in any activity or business permitted under the laws of the United States and Florida.

This right is waived by any holder of common stock who does not exercise it and pay for the stock preempted within thirty days of his receipt of a written notice from the corporation inviting him to exercise the right. A holder

of common stock shall not have, solely because of his holdings of common stock, a right to purchase shares of preferred stock that may be issued.

A holder of preferred stock shall not have solely because of his holdings of preferred stock a right to purchase shares of any class that may be issued by the corporation.

ARTICLE VII. INITIAL REGISTERED OFFICE AND AGENT
