THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is **BLUE LAGOON PROPERTIES, INC.**

ARTICLE II

The principal office and mailing address of the corporation shall be:
