# ERTICLES OF INCORPORATION

### GIORGIO'S PIZZA & SUBS. INC.

The undersigned, for purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

# 1. NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the corporation shall be GIORGIO'S PIZZA & SUBS, INC.. The principal place of business of this corporation shall be 1219 Homestead Road, Lehigh Acres, Lee County, Florida 33936.

# 7. DIRECTORS.

The number of the members of the Board of Directors may either be increased or decreased from time to time by the Bylaws, but shall never be less than one (1). The corporation shall have two (2) directors.

# 8. OFFICERS.

By business and affairs of the corporation shall be carried out the Officers of the corporation, which shall be elected by the Board of Directors pursuant to the provisions of the Bylaws of the corporation and which shall serve as provided in the Bylaws. The number of the Officers of the corporation may be either increased or decreased from time to time pursuant to the terms of the Bylaws.

# 9. PREEMPTIVE RIGHTS

- A. - B. Any obligation that the corporation may issue or sell which is convertible into or exchangeable for any stock of the corporation of any class or classes, or to which is attached or pertinent any warrant or warrants or other instruments conferring on the holder the right to subscribe for or purchase from the corporation any shares of its stock of any class or classes.

This right shall be deemed waited by any shareholder who does not exercise it and pay of the shares preempted within thirty (30) days after receipt of written notice from the corporation stating the price, terms and conditions of the issue of shares and inviting the shareholder to exercise this preemptive right. This right may also be waived by a written waiver signed by the shareholder.

## 10. BYLAWS

The power to adopt, alter, amend or repeal bylaws shall be vested in both the Board of Directors and the shareholders. Bylaws adopted, altered, amended or repealed by the shareholders of the corporation may not be repealed, altered, amended or readopted by the Board of Directors if the shareholders so provide.
