

ARTICLES OF INCORPORATION
OF

Generic Insurance Agencies of North Central Florida, Inc.
a Florida Corporation

The undersigned, acting as Incorporator of a corporation
under the Florida General Corporation Act, adopts the following
Articles of Incorporation for such corporation.

ARTICLE I
CORPORATE NAME AND PRINCIPAL OFFICE

The name and principal office of this Corporation shall be:

ARTICLE II
NATURE OF CORPORATE BUSINESS

The Corporation may engage in or transact any or all
activity or business permitted under the laws of the United
States and of the State of Florida.

ARTICLE III
CAPITAL STOCK

The Corporation is authorized to issue and have outstanding
at any one time a total of Five Hundred (500) shares of Common
Stock having a par value of One Dollar (\$1.00) per share. The
consideration to be paid for each share of stock shall be fixed
by the Board of Directors.

ARTICLE IV
PREEMPTIVE RIGHTS

All shareholders of the Corporation shall be vested with
full preemptive rights.

ARTICLE V
EXISTENCE

The Corporation shall have a perpetual existence, unless
sooner dissolved according to law.



CUMULATIVE VOTING FOR DIRECTORS

At all elections of the directors of this corporation, each shareholder shall be entitled to as many votes as shall equal the number of votes which (except for these provisions as to cumulative voting) he would be entitled to cast for the election of directors with respect to his shares of stock multiplied by the number of directors to be elected, and he may cast all such votes for a singular director, or may distribute them among the

number to be voted for, or any two or more of them, as he may see fit.




