Articles of Incorporation

The undersigned, acting as Incorporator of a corporation under the Florida Business Act, adopt the following Articles of Incorporation for such corporation:

Article I Name Of Corporation

Article III Capital Stock

The number of shares the corporation is authorized to issue is 1000 shares. The stock shall be one class.

Article IV Preemptive Rights

Each shareholder of this corporation shall have the right to purchase shares of any class, kind or series of stock in this corporation that may from time to time be issued, including shares from the treasury of this corporation, in the ratio that the number of shares he holds at the time of issue bears to the total number of shares by any shareholder who does not exercise it and pay for the shares preempted within thirty(30) days of receipt of a notice in writing from the corporation, stating the prices, terms and conditions of the issue of shares, and inviting him to exercise his preemptive rights. This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty(30) days of the receipt of the notice from the corporation.

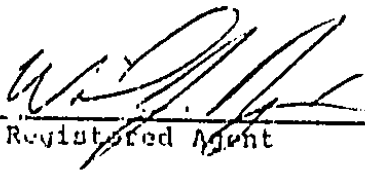
