ARTICLES OF AMENDMENT

OF

NORTHERN DREAMBUILDERS CORPORATION



Pursuant to the Florida Business Corporation Act, NORTHERN DREAMBUILDERS CORPORATION, a Florida corporation (the "Corporation"), hereby submits the following amendment to the Corporation's Articles of Incorporation:

- 1. The name of the Corporation is NORTHERN DREAMBUILDERS CORPORATION
- 2. The text of each amendment of the Articles of Incorporation of the Corporation is as follows:

Article III of the Articles of Incorporation of the Corporation relating to authorized shares of the Corporation is hereby deleted in its entirety and the following Article III substituted in lieu thereof:

"III. The aggregate number of shares which the Corporation shall have authority to issue is 10,000, divided into two classes of no par value common stock, voting and non-voting stock. The designation and number of shares of each class of stock is as follows:

<u>Class</u>	Number of Shares
Common Voting Stock	100
Common Non-Voting Stock	9,900

The designations and the powers, preferences and rights and the qualifications, limitations or restrictions thereof of each class of stock are as follows:

- (A) <u>Dividend and Liquidation Rights</u>. The Common Voting Stock and Common Non-Voting Stock of the Corporation shall be entitled to such dividends, if any, that may be declared in the discretion of the Board of Directors. Both classes of shares shall share in liquidation proceeds and dividends on the same basis.
- (B) <u>Voting Rights</u>. Each share of issued and outstanding Common Voting Stock of the Corporation shall be entitled to one (1) vote. The Common Non-Voting Stock shall have no voting rights except as otherwise required by law."
- 3. The date of adoption of the foregoing amendment was JANUARY 10, 2003.
- 4. The foregoing amendment was unanimously approved by all shareholders as follows and complies with the provisions of the Florida Business Corporation Act:
