The undersigned incorporator, who is a licensed physical therapist in the State of Florida, hereby adopts the following Articles of Incorporation with the intention of forming a professional corporation under Chapter 621, Florida Statutes (1995).

ARTICLE I

Corporate Name and Address

The name of the corporation is KATHY J. GAJEWSKI, P.A., and the initial street and mailing address of its principal office is: Suite 3, 2200 N. Ponce de Leon Boulevard, St. Augustine, FL 32084.

ARTICLE II

Nature of Business

The corporation is organized for the following purposes:

- a. To engage in the practice of physical therapy as a professional corporation and operate a physical therapy clinic.
- b. To furnish related clinical services, own or lease real and personal property, enter into contracts, and engage in any lawful business necessary to render such physical therapy services.
- c. To do everything necessary, proper, or convenient to accomplish any of the purposes set forth in these articles, and every other act incidental to the corporate purposes which are not forbidden by Florida law.
- d. The professional services of this corporation shall be carried out solely by its officers, employees and agents, each of whom has been duly licensed or otherwise legally qualified to render physical therapy in Florida.

ARTICLE III

Shares of Stock

The number of shares this corporation will be authorized to

issue or have outstanding at any one time is: 100 shares of common stock at a par value of \$1.00 per share.

ARTICLE IV

Term of Existence

The corporation's existence shall be perpetual, or until dissolved by a majority vote of the shareholders.

ARTICLE V

Initial Officer and Director

The sole initial officer and director is Kathy J. Gajewski, whose mailing address is 641 Howard Place, St. Augustine, Florida 32086. However, the number of directors and officers may be increased or decreased in accordance with the corporate by-laws.

ARTICLE VI

Incorporator

The name and address of the sole incorporator is: KATHY J. GAJEWSKI, 641 Howard Place, St. Augustine, Florida 32086.

ARTICLE VII

Initial Registered Agent and Registered Office
