ALLANASSEE TEORIES The undersigned incorporator, who is a licensed physical therapist in the State of Florida, hereby adopts the following Articles of Incorporation with the intention of forming a professional corporation under Chapter 621, Florida Statutes (1995).

ARTICLE I
