

The name of this Corporation is: FADI ALGHRAOUI M.D., P.A.

ARTICLE II

This Corporation is organized for the purpose of a medical practice and transacting any and all lawful business for which corporations may be formed under Chapter 607 of the Florida Statutes.

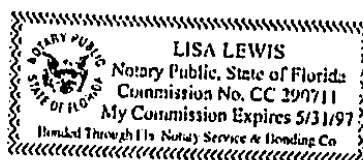
