I.

NAME

THE NAME OF THIS CORPORATION SHALL BE: T & G CUSTOM MARINE, INC.

II.

NATURE OF BUSINESS

THE GENERAL NATURE OF THIS BUSINESS TO BE TRANSACTED BY THIS CORPORATION IS BOAT PAINTING & DETAILING


