ARTICLES OF INCORPORATION OF

AMERICAN AVIATION SERVICES, INCUMSEE FLORIDA

I, RICKKI D. SOVERNS, being of legal age, do hereby sign these presents for the purposes of becoming a corporation under the laws of the State of Florida authorizing the formation of corporations.

ARTICLE I

The name of the corporation shall be:

AMERICAN AVIATION SERVICES, INC.

ARTICLE II

This corporation shall exist perpetually unless sooner dissolved according to law.

ARTICLE III

The general nature of the business and the objects and purposes to be transacted and carried on are to do any and all of the things herein mentioned, as fully and to the same extent as natural persons might or could do, viz:

- A. Establishment and operation of any lawful business permitted under the laws of the United States and of the State of Florida.
- B.
