THE UNDERSIGNED, acting as sole incorporator of Successor Records Corp. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name

**Initial Board of Directors**

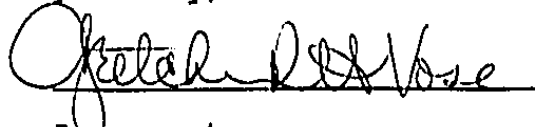
The corporation shall have no directors and shall be managed by its shareholders.

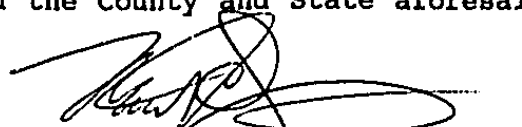

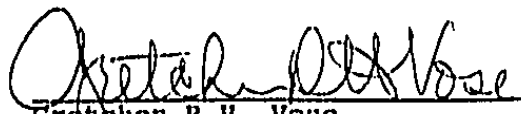
