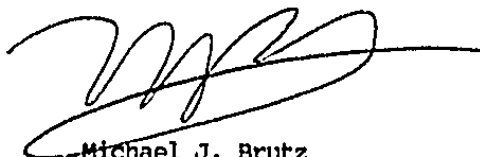

Name

The name of this Corporation is Elizabeth Hirsch Enterprises,
Inc.

ARTICLE II
