

Name of Corporation

1. The corporate name shall be PUBLIC LAND CONSULTANTS, INC.

Principal Office and Mailing Address

Number of Shares

3. The aggregate number of shares the corporation is authorized to issue is one hundred (100) shares. Such shares shall be of a single class, and shall have a par value of ten dollars (\$10) per share.

Stockholders Rights

4. No preferences, limitations or relative rights, other than those provided by law, shall exist in respect of any of the shares of the corporation or any of the holders thereof.
