# ARTICLES OF INCORPORATION

The undersigned, does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

#### ARTICLE I - NAME

The name of this corporation is AIR TECH ENGINEERING, INC.

This corporation shall commence its existence upon filing and shall exist perpetually thereafter unless scener dissolved according to law.

#### ARTICLE VI - PREEMPTIVE RIGHTS
