ARTICLE OF INCORPORATION OF "GEE WIZARD INC."

The undersigned, acting as incorporator of a corporation under the Florida Corporation act, adopt the following Articles of Incorporation for such Corporation.

1. The name of the corporation is **GEE WIZARD INC.**
2. The period of its duration is perpetual.
3. The purpose is to engage in any activity or business permitted under the laws of United States and of the State of Florida.
4. The Corporation shall have authority to issue five hundred (500) shares all in one class, one dollar (1.00) per value.
5. The address of its initial register office is **350 E. Jackson Street #1401 Orlando, Fl. 32801** and the name of its initial register agent at said address is **Mary Thompson**. The principal place of business is the same as above.
6. The number of directors constituting its initial Board of Directors is one (1) whose name and address is:

The pre-emptive rights of any holder and all shares of common stock currently held by the holder and all shares of common stock currently authorized and issued.




