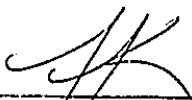

ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

amendment hereto, and any right conferred upon shareholders is subject to this reservation.

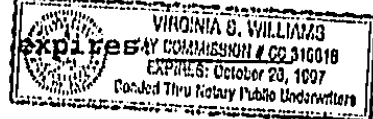
