

Wo, the undersigned, hereby associate ourselves together for the purpose of forming a corporation for profit under the general Corporation laws of the State of Florida in accordance with the following Certificate of Incorporation;

ARTICLE I NAME

The name of the corporation shall be LENARDS HEATING & COOLING, INC. Its principal place of business shall be, 105 Sylvania Ave. Englewood, Florida 34223, in the City of Englewood and the State of Florida. The mailing address of the Corporation shall be same, but the Corporation shall have the power to transact business at such place or places as the Board of Directors may designate, and branch offices of places of business may be established in such places within or without the State of Florida as the Board of Directors from time to time may direct.

ARTICLE II DURATION

The term of existence of the corporation shall be perpetual, or until dissolved according to law.

ARTICLE III POWERS OF CORPORATION

This corporation shall have the power to:

- 1. To have perpetual succession by its corporate name.
- 2. To sue and be sued, complain and defend in its corporate

name in all actions and proceedings,

- To have a corporate seal which may be altered at pleasure, and to use the same causing it, or a facaimile thereof, to be impressed or affixed or in any other manner reproduced.
- 4. To don! In, but not limited to residential and commercial heating and air conditioning services, as well as all other related services.
- 5. To purchase, take, receive, lease or otherwise acquire, own, hold, improve, use and otherwise deal in and with, real or personal property, or any interest therein, wherever situated.
- 6. To sell, convey, mortgage, pledge, create a security in, lease, exchange, transfer and otherwise dispose of all or part of its property and assets.
- 7. To lend money and use its credit to assist its officers and employees in accordance with law.
- 8. To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the corporation may determine, Issue its notes, bonds and other obligations, and secure any of its obligations by mortgage or pledge of any or all of its property, franchises and income.
- To lend money for its corporate purposes, invest and reinvest it funds, and take and hold real and personal property as security for the payment of funds so loaned and invested.
- 10. To have and exercise all powers necessary or convenient to effect its purposes.

ARTICLE IV CAPITAL STOCK

This corporation is authorized to issue 1000 Shares of common stock which shall be designated "Common Shares", with a \$1.00 par value.

ARTICLE V STOCKHOLDERS' RIGHTS DETERMINATION OF CONSIDERATION FOR WHICH SHARES ARE TO BE ISSUED

The stockholders shall have the right to determine in every instance the consideration for which the shares of the corporation

shall be lanued, which amount shall not be loss than the stated par value per share. The consideration for issuance of said shares, or any part thereof, shall be money current of the United States of America, or property, or services of value at least equivalent to the stock issued as fixed and determined by the Board of Directors of said corporation. Whenever any share or shares of stock are issued in consideration of payment to be made in property or in services, the fair and just value of the property to be transferred or the services performed or rendered, or to be performed or rendered, as a consideration for the issuance of said stock shall be fixed by the Board of Directors of said corporation. Any and all shares of stock of this corporation which shall be issued for consideration, or for not less than the consideration fixed and determined aforesaid, whether such consideration shall be cash, property, or services, shall be fully paid and nonasessable.

ARTICLE VI NUMBER OF DIRECTORS

The corporation shall have (1) director who shall serve for a period of (1) year. The number of directors may be increased or diminished from time to time and the length of time served by a director may change from time to time by By-Laws adopted by the stockholders, but the number of directors shall never be less than (1).

ARTICLE VIII INDEMNIFICATION DIRECTORS

The corporation shall indemnify any person who was or is a party or is threatened to be made a party to any threatened, pending or completed action, suit or proceeding, whether civil or criminal, administrative or investigative, by reason of the fact that he is or was a director, officer, employee or agent of the corporation, or is or was serving at the request of the corporation as a director, officer, employee or agent of another corporation, partnership, joint venture, trust, or other enterprise, against expenses (Including attorneys' fees), judgments, fines and amounts paid in settlement, actually and reasonably incurred by him in connection with such action, suit or . 'ncluding any appeal thereof, if he acted in good 'anner he reasonably believed was lawful. However. W respect to any action by or in the right of the corporation igment in its favor, no indemnification shall be made ______ect of any claim, issue or matter as to which such person is adjudged liable for negligence or misconduct in the performance of his duty to the corporation unless, and only to the extent that, the court in which much action or mult was brought determines, on application, that despite the adjudicate of Alability, such person is fairly and reasonably entitled to indomnify in view of all the circumstances of the case. Any indomnification herounder shall be made only on a determination by a majority of disinterested directors, subject to the approval of a majority of stockholders, that Indemnification is proper in the particular circumstances because the party to be indemnified has met the applicable standard of conduct. Determination of any such action, suit or proceeding by judgment order, settlement, conviction, or on a plea of nolo contender or its equivalent, shall not, of itself, create a presumption that the party did not meet the applicable standard of conduct. Indemnification hereunder may be paid by the corporation in advance of the final disposition of any action, suit or proceeding, on a preliminary determination that the director, officer, employee or agent met the applicable standard of conduct on receipt of an undertaking by or on behalf of the director, officer, employee or agent to repay such amount, unless it is ultimately determined that he is entitled to be indemnified by the corporation as authorized in this section.

B. The indemnification provided for herein shall continue as to any person who has ceased to be a director, officer, employee or agent, and shall inure to the benefit of the heirs, executors and administrators of such person.

ARTICLE XIV BY-LAWS
