ARTICLES OF INCORPORATION

ARTICLE_I

Name

The name of the corporation shall be THREE DAUGHTERS AUTO, INC.

ARTICLE_II

Duration

This corporation shall exist perpetually.

Purpose

ARTICLE_IV


Capital Stock


