

The undersigned subscribe to these Articles of Incorporation to form a corporation for profit under the laws of the State of Florida.

**ARTICLE I**

The name of this Corporation is **Pride Investments, Inc.**, and its initial post office address and its principal office for the conduct of business is 152 Springdale Circle, Palm Springs, Florida 33461.

**ARTICLE II**

This Corporation shall exist perpetually.

**ARTICLE III**

This Corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.


#### **ARTICLE XI**
