ARTICLE I - NAME AND ADDRESS

The name of this Corporation is: WHITE TIGER TATTOO STUDIO, INC. And the address of the Corporation is 1030 N. Washington Blvd., Sarasota, Florida 34237.

ARTICLE II - DURATION

This Corporation shall exist perpetually.

ARTICLE III - PURPOSE

This Corporation is organized for the purpose of any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act, and any activity of business permitted under the laws of the United States. The general nature of this business to be transacted by this Corporation is the operation of a tattoo and piercing studio.

ARTICLE IV - POWERS

This Corporation shall have all of the corporate powers enumerated in the Florida General Corporation Act.

ARTICLE V - CAPITAL STOCK

This Corporation is authorized to issue 1,000 share of common stock having a par value of One (\$1.00) Dollar per share. Authorized capital stock may be paid for in cash, services or property, at a just value to be fixed by the Board of Directors of this Corporation at any regular or special meeting.

ARTICLE VI - INITIAL CAPITAL

The amount of Capital with which the Corporation shall begin business is One Hundred (\$100.00) Dollars.

ARTICLE VII

Every shareholder shall have the right to purchase his pro-rata share of any new stock of this Corporation of the same kind, class or series as that which he already holds at the price at which it is offered to all other shareholders.

ARTICLE VIII - INITIAL OFFICE AND REGISTERED AGENT

The street address of the initial registered officer of this Corporation is 118 30th Street N.W., Bradenton, Florida 34205, and the name of the initial registered agent of this Corporation at this address is JONI L. HINKLE.

ARTICLE IX - DIRECTORS

This Corporation shall have one director initially. The number of directors may be either increased or decreased from time to time by the By-Laws, but shall never be less than one. The name and post office address of the members of the first Board of Directors of this Corporation are:

ARTICLE X - TRANSACTIONS

No contract or other transaction between this Corporation and any other corporation and no act of this Corporation shall be affected in any way or invalidated by the fact that any of the Directors or Officers of the Corporation are pecuniarily or otherwise interested in, or are directors or officers of such other corporation. Any director or officer individually, or any firm of

which any director or officer may be a member, may be a party to, or may be pecuniarily or otherwise interested in, any contract or transaction of the Corporation, provided that the fact he or such firm is so interested shall be disclosed or shall have been known to the Board of Directors or such members thereof as shall be present at any meeting if the Board of Directors at which action upon such contract or transaction shall be taken;

and any director of the Corporation or who is also a director or officer of such other corporation or who is so interested may be counted in determining the existence of quorum at any meeting of the Board of Directors, which shall authorize any such contract or transaction and may vote there as to authorize any such contract or transaction, with like force and effect as if he were not such director or officer of such other corporation or not so interested.

ARTICLE XI - INCORPORATOR

ARTICLE XII - BY-LAWS

The power to adopt, alter, amend or repeal by-laws shall be vested in the shareholders.

ARTICLE XIII - OFFICERS

This Corporation shall have the following officers: President, Vice President, and Secretary-Treasurer. The By-Laws of the Corporation may, at any time, establish and provide for the offices of Assistant Secretary and Assistant Treasurer and such office(s) as may be deemed necessary.

ARTICLE XIV - INDEMNIFICATION

The Corporation shall indemnify any officer or any former officer to the full extent permitted by law.

ARTICLE XV - AMENDMENT

This Corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, and any amendments hereto, and any right conferred upon the shareholder is subject to reservation.

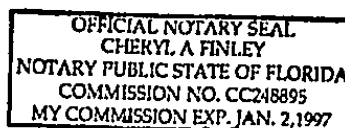
