The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following articles of incorporation for such corporation:

ARTICLE I. NAME AND ADDRESS: The name and address of the corporation is: TIKI ENTERPRISES, INC., 620 Forest Lane, Deland, Florida 32724.


