Name

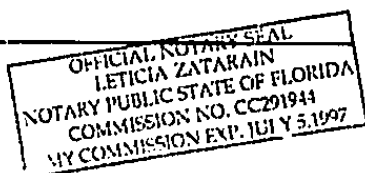
