
1. The name of the organization is Cintra & Duvekot Consulting Company.
2. The principal place of business and mailing address of the corporation is: 117 South 17th Avenue, Hollywood, Florida 33020.
3. The specific purpose for which the corporation is organized is to provide advisory, support and consulting services to clients who are engaged in international trade activities.
