ARTICLES OF INCORPORATION

MFL, INC.

The undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, and desiring to form a corporation under the laws of the State of Florida, hereby certifies as follows:

ARTICLE 1 - NAME AND ADDRESS

The name of the corporation is MFL, Inc. and the address of its principal place of business is 1637 East Vine Street, Suite E, Kissimmee, Florida 34744.

ARTICLE II - DURATION
