The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is:
CONCRETE CURBING, INC.

Article 2. The principal office and address of the corporation shall be located at:

Article 3. Duration. The duration of the Corporation is perpetual.

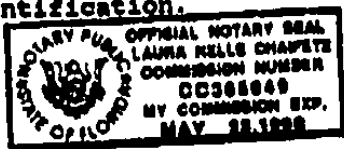
