The undersigned Incorporator, for the purposes of forming a corporation under Chapter 607 of the Florida Statutes, adopts the following Articles of Incorporation for such corporation:

ARTICLE I.

The name of the corporation is **RAINNER AND COMPANY, INC.**

ARTICLE II.

The duration of the corporation is perpetual.

ARTICLE III.

The propose for which the corporation is organized is to engage in the business of insurance planning through the sale of life insurance and disability insurance; of investment planning through the sale of annuities and mutual funds; and estate tax planning through the use of trusts and sale of life insurance and to do those things which are necessary and proper in connection with that business, with all powers conferred on corporations by the laws of the State of Florida.

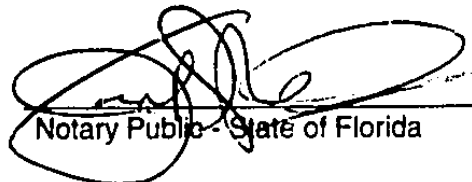
