#### ARTICLES OF INCORPORATION

ELVIRA A. MANALAYSAY and GEORGIA T. ALANO, natural persons competent to contract do hereby make, subscribe, acknowledge and file in the office of the Secretary of State of the State of Florida for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida, these Articles of Incorporation, as by law provided.

#### ARTICLE I NAME

The name of this corporation shall be as stated above as CREW TELECOMMUNICATION SERVICES, INC.

## GENERAL NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the Untied States of America and the State of Florida.

#### ARTICLE III CAPITAL\_STOCK

The maximum number of shares of captial stock authorized to be issued by this corporation shall be <u>FIVE HUNDRED (500)</u> shares having a par value of <u>ONE DOLLAR (\$1.00)</u> per share. Each of said shares of stock shall entitle the holder thereof to one (1) vote at any meeting of the Stockholders. All or any part of said capital stock may be paid for in cash, in property (other than stock or securities), or in labor or services at a fair valuation to be fixed by the Incorporators, or by the Board of Directors, at a meeting called for such purpose. #### ARTICLE V TERM OF EXISTENCE

This corporation shall have perpetual existence.
