ALANO, natural persons competent to contract do hereby make, subscribe, acknowledge and file in the office of the Secretary of State of the State of Florida for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida, these Articles of Incorporation, as by law provided.

# ARTICLE I

The name of this corporation shall be as stated above as MANILA SHANGRILA RESTAURANT, INC.

# GENERAL NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the Untied States of America and the State of Florida.

### ARTICLE III CAPITAL STOCK

The maximum number of shares of captial stock authorized to be issued by this corporation shall be <u>FIVE HUNDRED (500)</u> shares having a par value of <u>ONE DOLLAR (\$1.00)</u> per share. Each of said shares of stock shall entitle the holder thereof to one (1) vote at any meeting of the Stockholders.
