**ARTICLE I - NAME**

The name of this corporation is WALKER & WIEHAUS ENTERPRISES, INC.

**ARTICLE II - DURATION**

This corporation is to have perpetual existence.

**ARTICLE III - PURPOSE**

This corporation is authorized for the purpose of transacting any and all lawful business.

**ARTICLE IV - CAPITAL STOCK**
