ARTICLE I: CORPORATE NAME

The name of this corporation is PYRA, INC. The business address and telephone number of this corporation are:

ARTICLE II: DURATION

The duration of this corporation shall be perpetual. Corporate existence shall commence at the time of filing the Articles of Incorporation with the Department of State.

ARTICLE III: PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the laws of Florida.

ARTICLE IV: CAPITAL STOCK

A. Number:

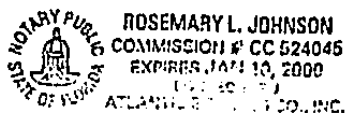
