

The undersigned, who is a Doctor of Optometry, and duly licensed in the State of Florida, desiring to create a professional corporation, in accordance with Chapter 607 of the Florida Statutes, and the Florida Professional Service Act, adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be:
