

ARTICLES OF INCORPORATION

We, the undersigned, hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida, and do hereby adopt the following:

Article I

The name of the corporation shall be:

Article II

The corporation shall have a perpetual existence.

Article III

This corporation may engage in any activity or business permitted under the laws of the State of Florida.

Article IV

The corporation is authorized to issue five hundred (500) shares of one dollar (\$1.00) par value common stock which shall be designated "Common Shares". Said shares of stock shall be issued, sold, or transferred only according to the Bylaws of the corporation.


Article X

The corporation shall indemnify any officer and/or director or any former officer and/or director to the full extent permitted by law.



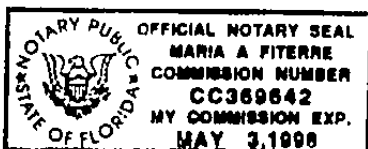
